Government Contracts - Daily Acts works in collaboration with a number of municipalities/agencies in Sonoma County including City of Petaluma, City of Cotati, City of Sebastopol, City of Santa Rosa, Sonoma County Water Agency and Town of Windsor. The work with municipalities is predominantly focused on water conservation initiatives. Over the past six years, Daily Acts has helped to transform thousands of square feet of water-thirsty lawn into productive edible gardens, and supported the installation of dozens of home-scale greywater and rainwater harvesting systems. Daily Acts has facilitated dozens of sustainability tours that have inspired and educated Sonoma County residents to live a more ecologically sustainable lifestyle.

Homegrown Program - Model Households, Garden Wheel, Seasonal Celebrations, Homegrown Guild Yahoo Group, Permaculture Design Certification - provide citizens support to turn inspiration into action to live a more nourishing existence while radically reducing their footprint on the planet. Homegrown Programs build household and community self-reliance by transforming home and landscapes into productive, resilient ecosystems. Through Homegrown Programs, Daily Acts grows hope, community, skills education, habitat, policy change and engaged citizens who are feeding and inspiring neighbors and reclaiming the future.

The Community Resilience Challenge (CRC) is an annual community mobilization campaign organized by Daily Acts that has inspired thousands of individuals, groups, and community leaders to take action to save water, grow food, conserve energy, reduce waste, and build community. The CRC not only inspires action, it fosters collaborations, builds relationships, and strengthens networks for lasting change.
